Canada is a G7, G8 and G20 Member Country, and prides itself as one of the most popular countries in the world. It covers an area of approximately 9.985 million km² stretching from the USA in the South to the Arctic Circle in the North. The capital city is Ottawa. The metropolitan city of Toronto is the 4th largest city in North America. Canada's population increased by 530,000 in 2019 of which 340,000 was through immigration, the highest increase amongst the G7 countries. Canada's immigration targets for the next 3 years are 401,000 immigrants in 2021, another 411,000 in 2022, and 421,000 in 2023

BENEFITS

- ◆ As a Canadian residency holder, you, your spouse and children up to the age of 21, have the rights for free health care, free education up to high school, local university tuition fees anywhere in Canada.
- ◆ Eligible to apply for a Canadian permanent residency within 2 years
- ◆ A Canadian Permanent Residence gives you access to 23 countries
- ◆ A permanent resident of Canada can apply for Canadian Citizenship after living in Canada 3 years out of 5 years

STEPS AND PROCEDURES

- ◆ ROC Citizenship will qualify the applicant to ensure eligibility, through initial questionnaire and business assessment
- ◆ Applicant to sign with ROC Citizenship
- ◆ Financial statements for funds verification
- ◆ Canadian federal and provincial corporation setup
- ◆ Canadian shareholder agreement
- ◆ Canada virtual office and business number agreement
- ◆ Medical
- ◆ Security Clearance

REQUIREMENTS

BRANCH OPTION (WITHOUT IMMIGRATION)

- ◆ Existing business portfolio
- ◆ Owner passport copy and address
- ◆ Business registration

BRANCH OPTION (IMMIGRATION)

- ◆ Company has been registered in country of operation for more than 1 year
- ◆ Minimum net worth \$150,000
- ◆ Statements reflecting net worth
- ◆ No Criminal Record
- ◆ No serious medical condition

OPTIONS

BRANCH OPTION

- ◆ Open a branch location of your existing business
- ◆ Minimum of CAD \$125,000 includes VAT

NEW BUSINESS OFFICE

- ◆ Open a new business office
- ◆ Minimum of CAD \$150,000 includes VAT

INVESTMENT INTO AN EXISTING BUSINESS

- ◆ Investment into an existing business
- ◆ Cost of running business may vary depending on the business
- ◆ Minimum of CAD \$150,000 includes VAT
