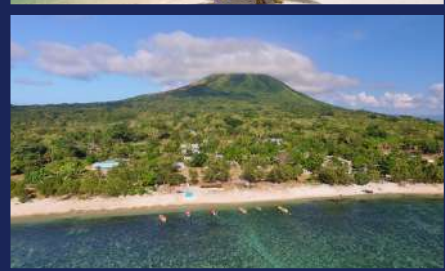

## BENEFITS

## INVESTMENT OPTIONS

- ◆ USD \$130,000 Government donation for single applicant
- ◆ USD \$15,000 additional for each under aged dependant child
- ◆ USD \$20,000 additional for dependant spouse
- ◆ USD \$100 Application fees per applicant
- ◆ USD \$3,000 FIU due diligence fees
- ◆ USD \$100 Citizenship certificate fee per applicant
- ◆ USD \$170 Passport fees per applicant
- ◆ USD \$150 Fast track option (passport in 3 days after committee approval)

## REQUIRED DOCUMENTS

- ◆ Application form (DSP Nomination)
- ◆ Current passport
- ◆ ID (from applicant's country of birth/ similar to passport)
- ◆ Birth certificate
- ◆ Non-criminal record certificate
- ◆ Education diplomas
- ◆ Medical examination certificate
- ◆ Proof of the assets
- ◆ CV in English
- ◆ Reference letter from your bank + lawyer/accountant in English
- ◆ Passport photos (10 photos)

## STEPS AND PROCEDURES

- ◆ Client prescreening for eligibility
- ◆ Client signs letter of engagement and pays down payment on professional fees
- ◆ Collection and attestation of required documents
- ◆ Client pays Vanuatu State fees and government donation amount
- ◆ Client pays balance on professional fees. Submission of client's application
- ◆ Due diligence check
- ◆ Issuance of certificate of naturalization and passport
- ◆ Oath is taken in Dubai through the Vanuatu-Dubai official, hence client saves on travel expenses
